RULES AND REGULATIONS

Club Hours

Sunday: Noon to 10 p.m.

Monday- Thursday: 10 a.m. until 10 p.m.

Friday- Saturday: 10 a.m. until Midnight.

REGISTRY:

Member's guests shall sign the Club's registry book upon entering the Club. Members shall be accountable for their guests complying with dress code, as well as club rules. A fifteen (\$15.00) guest fee will be paid upon entering the lounge fee will be credited towards guest purchase of cigars.

GUEST POLICY:

For the purpose of HCC Guest Policy, the term guest is further defined as:

- Full member guest may bring up to three (3) guests, The same guests can't not be returning any more than three (3) times per given month.
- Spouse may accompany the Member without limitations.
- A Social Member can bring one (1) guest not more than two (2) times per given month.

DRESS CODE:

Member shall abide by HCC dress code, which is smart casual attire (business casual, professional, formal, etc.) The Club defines smart casual attire as neat and presentable collared shirts, casual pants, knee high shorts, and shoes. T-shirts, tank tops, sweat pants or jogging suits, Lycra or Spandex garments, baseball caps, flip flaps, ripped or frayed clothing and/ or footwear similar apparel are not permitted after 5 pm. Members and their guests are asked to respect the sensibilities of other members by striving to uphold standards of dignity and good taste in wardrobe selections.

YOUR INITIALS _____

MINORS:

Persons under the age of 21 are not permitted in the Club.

PETS:

Not pets allowed at the club except for service dogs.

CONDUCTING BUSINESS:

Business related documentation should be handled and displayed correctly. Quiet discussions and the use of papers and laptop devices with sound muted. Cellular phones may only be used in a manner that does not disturb other members or their guests. Texting is permitted with the sound muted. The display of merchandise or business products and solicitation of said products or services by members to other members and/ or guests is not permitted. The Club's name is not permitted for contact information on Members personal or business related correspondence or other materials.

MEMBER EVENTS.

Full members are encouraged to make reservations and respect RSVP dates.

PRIVATE HUMIDIFIED LOCKERS

- To avoid the potential for agricultural pest infestation of cigars stored in the Club's private lockers of full members, all cigars shall be inspected prior to being placed in the locker.
- Members are not permitted to install their own lock on a locker.
- Lockers cannot be used to store items that may violate any Federal, State or Local laws.
- The club is not responsible for articles left in the lockers or in other areas of the club.
- Management reserves the right to access any locker for the purpose of maintenance and inspection.
- Upon termination of membership, all locker contents must be removed within 24 hours or items shall be deemed abandoned and will be disposed of in any manner the Club elects.
- A fee of \$20.00 must be paid for the locker key, if the key is lost and a new one is needed the same amount will be charged. Key deposit will be returned upon termination of membership.

YOUR INITIALS _____

FOOD AND BEVERAGES ON PREMISES

No food is permitted in the Club nor is food allowed on the service bar counter at any time. Sponsored events are exempt from this rule. Members with permission to conduct a business meeting may request permission to bring appetizers to attendees. Members are permitted to bring alcoholic beverages to the club for personal consumption. Member acknowledges that the ability to consume alcohol in the Club is a privilege and Members of his guests will consume such alcohol in a responsible manner. Alcohol may be stored in Full member's lockers. Management reserves the right to remove and destroy any alcoholic beverage not under lock and key if member is not present.

MISCELLANEOUS

- No membership contact information may be shared with others without the written consent of the member(s).
- Boisterous or indecent conduct will not be tolerated in the Club. Members are encouraged to report such conduct to management.
- Member should leave the Club in the same condition as it was found upon arrival as a courtesy to others.
- Damage to the club furniture and fixtures as a result of Member carelessness or disregard shall be corrected at member expense.
- The Club reserves the rights, in its sole and absolute discretion, to alter, amend, rescind and add to those rules and regulations. Membership will be notified of such changes.
- The member shall hold the Club harmless from any and all liability in the event the member's action lead to some criminal or other legal liability.
- If legal action must be taken by the Club against any member and the Member is found to be liable then the member shall be liable for any damages assessed by the Court as well as any and all reasonable attorney's fees.
